ALERT: MBS Down Just Over an Eighth From Highs

Those lenders are now seeing an eighth of a point of weakness or slightly more. In limited cases of similar movement, the jumpiest lenders in that cohort have repriced for the worse in these situations.

Apart from those lenders, all other lenders would still be seeing prices that are higher than they were this morning.
