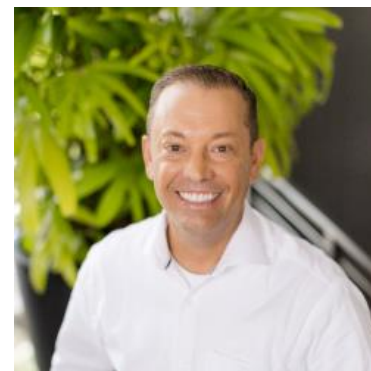


## The Day Ahead: Quiet Monday For Data. Bonds Staying on Defense Ahead of Inflation Reports
