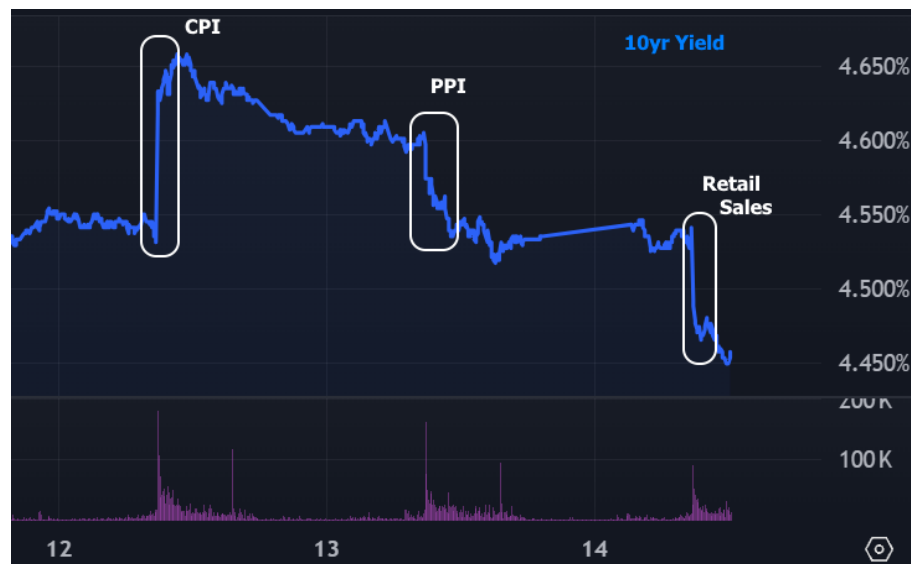




## The Day Ahead: Best Levels of The Week After Downbeat Data
