## **ALERT:** Down More Than an Eighth From Highs

Bonds were steady until about 9am and have been losing ground since then. 5.5 coupons are down 3 tick (.09) on the day and 6 ticks (.19) from the AM highs. Most lenders weren't out with rates at that time, so negative reprice risk is minimal, at best.
