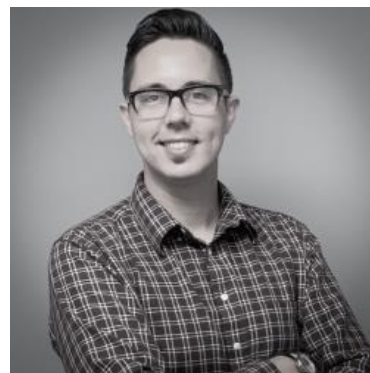
ALERT: Bonds Under More Pressure on Trade-Related Headlines
