With Jobless Claims on hold due to the shutdown, bonds are forced to endure another data-free morning. With that, bonds wait for the day's only real potentially significant event: the 1pm 30yr bond auction. We're seeing a bit of selling this morning, but it is very much an in-range affair so far as is anything with a yield between 4.08 and 4.20.
