

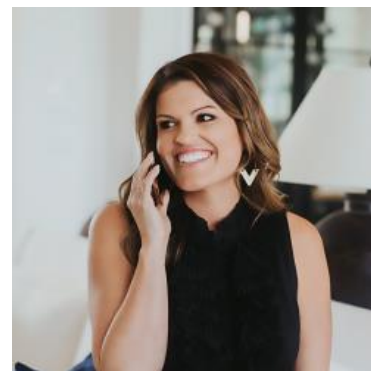

MBS are now down 9 ticks (.28) on the day and just over an eighth of a point from the AM price plateau. Some of the jumpiest lenders would be in a position to consider negative reprices.
