## UPDATE: MBS Surge Following Trump Comments

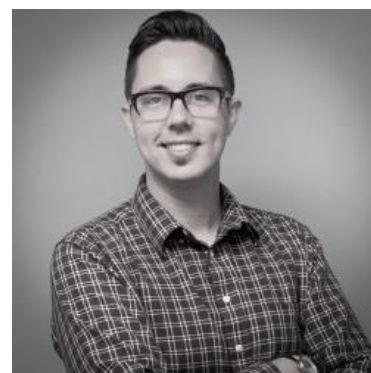
The newswire in question:
