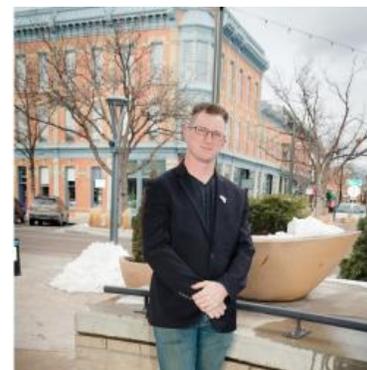


## The Day Ahead: Slower Start, More Sideways. Stock Lever in Play
