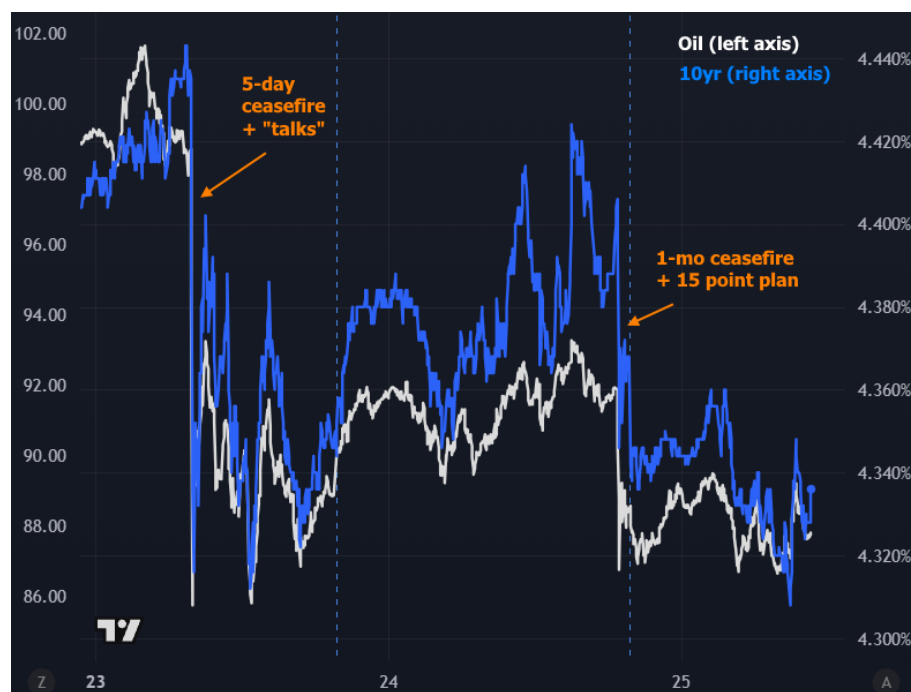


## The Day Ahead: Bonds Showing Some Optimism About Turning Point in The War
