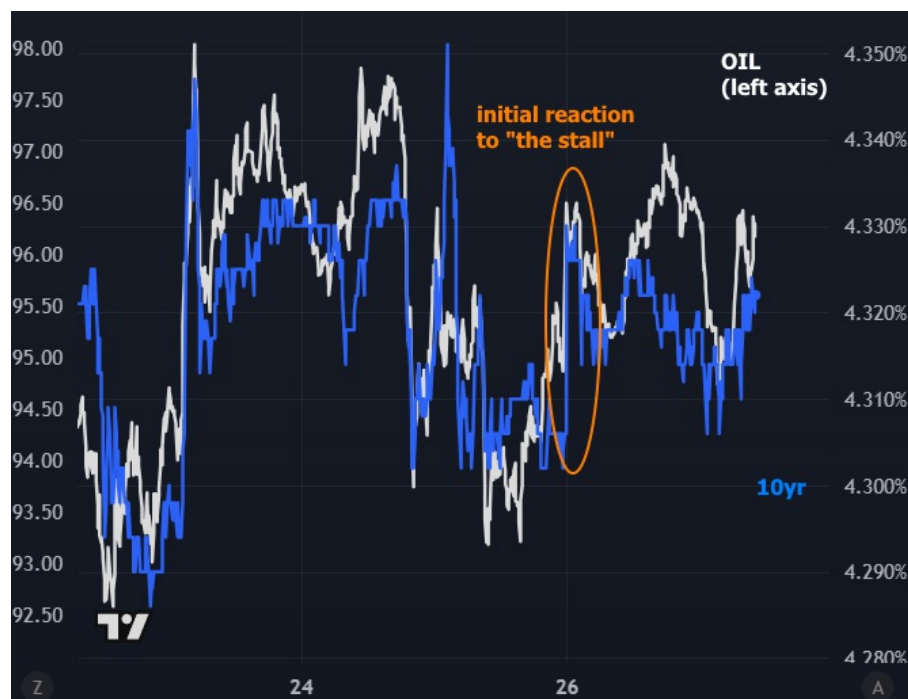

## The Day Ahead: Minimal Change Despite Lack of Progress in Peace Talks

The word of the day is "stalled." At that time, official word was that Witkoff/Kushner were heading to Pakistan on Saturday morning to meet with Iran's FM Araghchi, but the US contingent never made the trek. And stocks are actually in slightly stronger territory, once again pushing new all-time highs.
