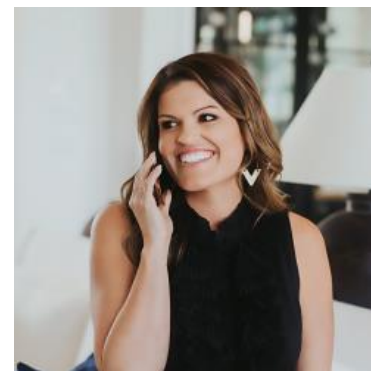
10yr yields are up 1.4bps at 4.361.
