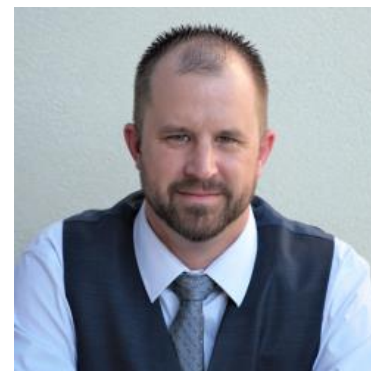


## The Day Ahead: Bleeding Subsides For Now, Headlines Helping But Bonds Remain Cautious
