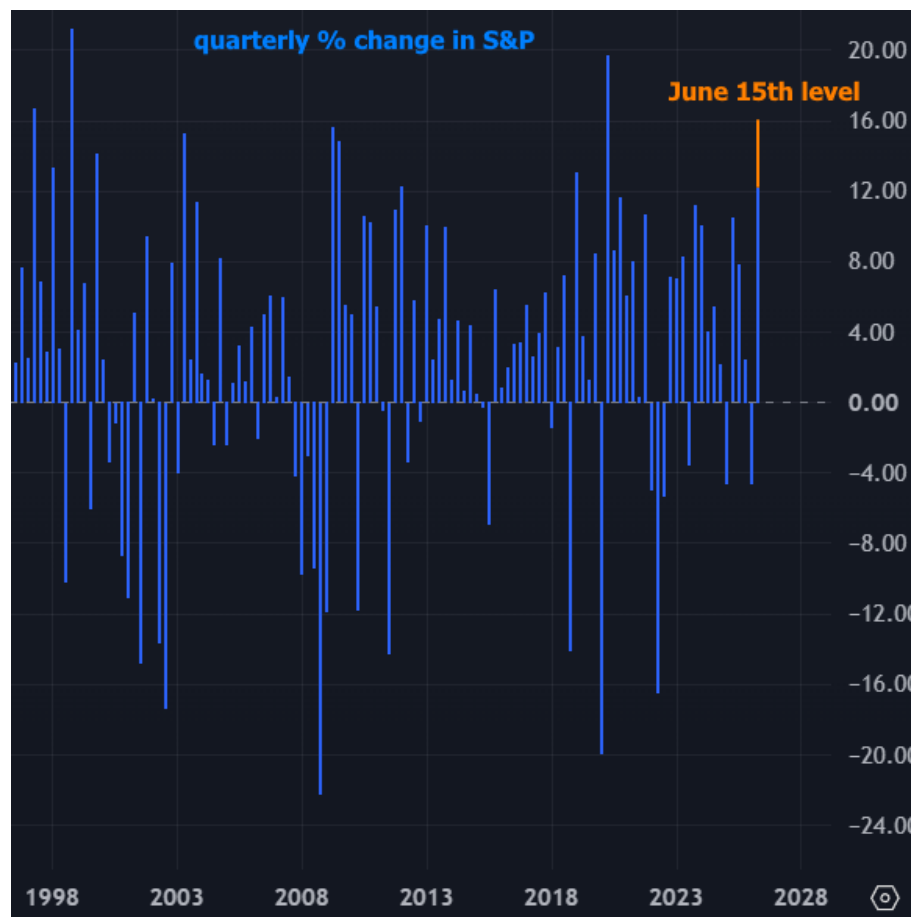




The Day Ahead: Sideways Start, Quiet Calendar, Quarter-End Volatility Potential

Bonds are starting out roughly unchanged and have little else to focus on thanks to an uneventful economic calendar.
