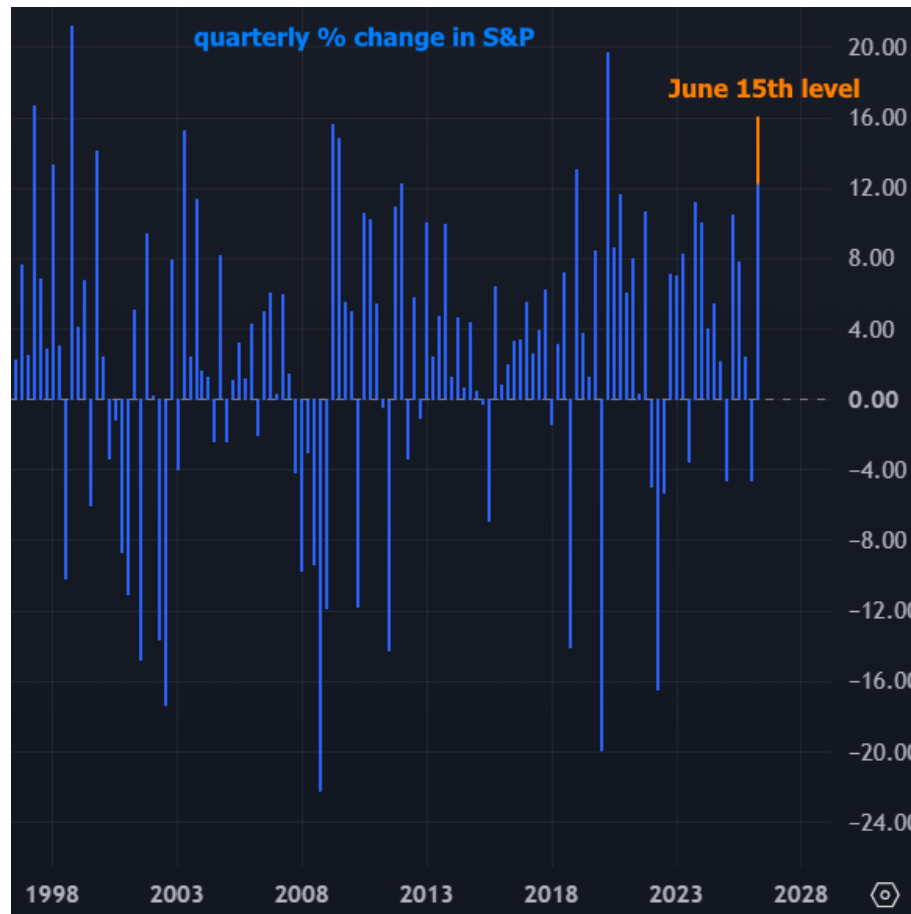




## The Day Ahead: Sideways Start, Quiet Calendar, Quarter-End Volatility Potential
