ALERT: MBS Down an Eighth From Rate Sheet Print Times

The early crowd of lenders tends to release rates by 10am or shortly thereafter. MBS prices are now down an eighth of a point since then (5.0 coupons are down a bit more).

The jumpier lenders are on the verge of repricing consideration. Most would want to see another tick or two of weakness before pulling the trigger, but it can't be ruled out as a risk.
